At the meeting of 21.11.25 council set a revenue budget in the sum of £4,382 which includes employment of clerk under contract, change in website provider; retention of services of internal auditor, anticipated bank charges and sum for unscheduled works on Church Meadow.

At the meeting of 21.11.24, council further indicated that it wished to set the precept to be levied on the parish at £4,000 with final decision deferred until the indicative tax base (14.11.24) was confirmed.

Proposal for meeting of 16.01.25: council sets its precept at £4,000 acknowledging that this will result in a band D council tax (parish element) of £56.48 which is an increase of 7.49% annum) equivalent to £3.94 per annum (7pence per week) over that set the previous year.
